Universal Service Program Bidding Process

The Crocker R-2 School District requests Request For Proposals (RFP's) on all items listed below for use during the coming school year. The Crocker R-2 Schools are making plans to purchase equipment to further expand and improve their current Internal Connections, Telecommunications Services, and Access to the Internet.

The Crocker R-2 School presently has two attached school buildings. Approximately 100% of the rooms in these buildings are wired for internal connections. The Network Infrastructure is 1Gbps/100mbps autosensing switched backbone with fiber between the switches.

- 2. Maintain long distance service
- 3. Maintain wireless services (cellular)
- 4. Maintain and expand fiber connections to all buildings for both voice and data transmissions
- 5. Add UPS equipment to all servers
- 6. Firewall Service
- 7. Network Maintenance Coverage
- 8. Wireless Solutions to accommodate the entire district

All RFP's shall include the necessary cost for labor to install and maintain the equipment during the warranty period. You should submit with your bid a current list of references and warranty information. The successful bidder must be able to present proof of Workman's Compensation and Liability Insurance Coverage. All bids must be submitted in a sealed envelope with the name of the bid and the time of the bid deadline clearly marked.

Deadline for bids is January 15, 2015, 4:00 p.m. Bids will be evaluated and presented to the Crocker R-2 Board of Education of January 20, 2015, at 6:30 p.m.

The Crocker R-2 School District will pay their percentage of the contracted price within 30 days of completion of the project. The remaining monies will be paid directly through the Universal Service Fund.

It is our request that the bids for equipment meet or exceed the standard for the brand names listed, but it is not the goal of this district to eliminate any bidder because their RFP calls for a different brand name of equipment.
